#### WHY DID THEY COME? - FROM A FREEDOM LOVING OTTAWA RESIDENT BETH BLACKMORE

#### Why did they come?

In November of 2021, when Ottawa was in the grips of government overreach, I was Acting Team Leader of Recruitment with the Federal Government. Our team was responsible for including the new condition of employment for covid vaccinations within the job posters and offer letters.

I, however, knew my fate. I knew that by not disclosing my private medical status I would be placed on leave. My last day working was December 8th, 2021.

January of 2022 I was feeling pretty hopeless. I remember thinking that the nation's capital was indeed the capital city of compliance, with public servants tucked away working in their homes earning their consistent pay. As a whole, the public service workforce that dominates Ottawa's industry was very much immune from the fallout of the government's lockdowns and overreach.

But rumours of a convoy had started circulating and momentum was building for a huge presence in Ottawa. After two years of miserable and unnecessary restrictions and mandates, a group of truckers rallied to have their voices heard.

Finally people who just wanted freedom of choice were assembling together and felt free for the first time in two years. I participated in the Adopt-A-Trucker program, we hosted the brave truckers, provided meals, showers, and laundry in appreciation of their sacrifice. While I acknowledge there were inconveniences that the Freedom Convoy brought to the nation's capital, we must remember why they came. They didn't come to personally inconvenience anyone. They came for dialogue and to be heard. And where else should they have gone? Ottawa, as so many seem to forget, is the nation's capital and should be the centre of Canadian democracy.

Still there were no measures taken to address the people's concerns or attempt to negotiate.

Not once did the PM offer an opportunity for a meeting, or delegate ministers to have a discussion. The PM treated them like invaders, not a representative group of Canadian citizens with relevant concerns.

So from no communication whatsoever to the Emergencies Act? The invocation of the EA quite literally trampled on our civil and human rights with police using brute force against a peaceful people and freezing bank accounts. It was politically motivated to preserve power and protect the policy-makers, which quite honestly destroyed an important pillar of our democracy - the right to protest and assemble.

The truckers and the protesters were merely trying to be heard.

Fortunately, due to the sheer size and enormity of the Freedom Convoy, it successfully evolved into a global movement that finally gave us a voice on the international stage.

There's no doubt the Freedom Convoy was responsible for putting an end to the government's unjust mandates...at least for now.

#### THE FORGOTTEN VICTIMS OF CANADA'S POLITICAL PERSECUTION Christy's Story

"You have one minute remaining on your call." A voice comes over the line while Christy, girlfriend of Freedom Convoy's Pat King, has to say goodbye again, hoping the man she loves can make it through another night in jail. When Pat was arrested it was 48 hours before she would hear from him. The anxiety and fear around the unknown, her emotions were high. With the media degrading Pat, spreading falsehoods about him, creating a narrative around his character that she knew was the furthest thing from the truth, all she could do was wait.

Pat's first bail hearing was the Monday after the arrest, unfortunately he was not granted bail and was taken back to wait 30 days before he could reapply. Christy stayed in the Air B&B until after the first hearing but had to return home to Sturgeon Falls soon after and the fight to get Pat released began.

With the struggle to find lawyers that would genuinely fight for him, she had a lot on her hands. Feeling left out in the cold by the system she found herself in a perpetual state of anxiety not knowing when she was going to be able to see him. Finally she was granted a visit after a month of their only communication being over a jail phone.

Pat's second bail hearing ended the same way the first did, heart break and uncertainty. With not being able to apply again for now 90 days, Christy decided she would go to Alberta and try to hold down his life while she could, but this meant their only contact would be over the phone. Pat's final bail hearing, in July of 2022, Christy was able to surprise Pat in court. He was not expecting her to be there but the timing was impeccable as this final bail hearing saw his release. Christy will never forget the sigh of relief, the emotion from both her and Pat, looking out the window of the plane while entering Alberta air space. They were finally home. While relieved she had Pat home, his bail conditions were extreme. Among a social media ban and no contact orders, Pat was given a curfew between 10pm and 6am police would knock at all hours of the night, showing up with their lights flashing and causing disturbance to their neighbors, to this day this is still happening.

Christy talks about the love she has seen from their community, the people that still support them and know the truth about who Pat really is and she feels it is important for people to be aware of. With all of the claims of racism thrown at Pat, she talks about the love they felt from the Sikh community. When Pat was released he had to post 25,000 for bail, one man Kalveer Grewal, raised this money for him and made sure he was there to help Pat reach this requirement. The love and respect from this community was heartwarming and will forever be something Christy remembers as a light in the midst of fog.



Going forward, Christy is confident that the evidence that will be presented at trial will exonerate Pat of any wrong doing. She is hopeful and encouraged and hopes for people to continue to search for the truth buried amongst the chaos.



### **HOLDING THE GOVERNMENT TO ACCOUNT** The Tragic Case of Carrie Sakamoto

Covid was a time of mixed emotions for a lot of people. The fear and anxiety took hold of society and many didn't know what to trust. Our governments were producing very emotionally driven propaganda focused of creating a state of perpetual panic amid the citizenry. Lines were drawn in the sand and the country started seeing the most poignant divide we had seen in modern day. If you took the vaccine you were a hero, the media, your friends and family applauded you, society expected it. If you did not, you were ostracized, shunned, and demonized by many of those same people.

Carrie Sakamoto did what she thought was right, what she thought she was supposed to do to protect those around her. She didn't understand those that saw something wrong, she trusted what the government was calling "the science" and took her first vaccine, AstraZeneca, in April of 2021. When she made the appointment to get her second vaccine AstraZeneca had been taken off the market due to blood clotting and so her option was Pfizer.

After her first vaccine, her side effects were typical and expected, flu like symptoms both her and her husband recovered from, however, after her Pfizer vaccine, everything changed for her. Side effects started immediately with flu like symptoms, but by the end of a weeks time Carrie was only getting more ill. She spoke with her Doctor who prescribed an antibiotic for the tonsil stones and said it was likely due to the fever she'd had.

That night, Carrie became the sickest she had been. She describes a burning sensation in her head, uncontrollable vomiting and she could not eat. While on her way to the hospital her face dropped, Carrie feared she was having a stroke. The hospital ran tests and determined she was experiencing Bells Palsy, something they said she would recover from and sent her home with steroids.

As the medication wore off Carrie's symptoms only worsened and she was taken back to the hospital. Soon the other side of her face started tingling and her right eye became paralyzed. This started a series of tests to find out what was happening to cause these symptoms.

Carrie feared she would be blind, having to now patch her right eye. She was put on feeding tubes for nutrition, given an MRI, CT scan, spinal tap and ultrasound and was finally provided with an answer. Her medical team agreed, this was caused by the vaccine. Through all of this, Carrie spent 16 more days in the hospital, isolated from her kids, few visits from her mother and husband due to hospital covid policies. She had to learn to speak again, learn to chew, swallow and walk, and still had no taste or smell. She currently still suffers from a loss of hearing and tightening of her face, the more she talks the more her face tightens, she is experiencing memory issues and has undergone testing concluding she may be experiencing early onset dementia.

Her family has had to sell everything, move from their acreage into the city, and she can no longer work. Every week she has different doctors appointments, and faces a future of complete uncertainty. Her frustrations grow with the silence from main stream media, and the lack of support for people whose lives have been destroyed by these vaccines. She hopes people will keep fighting and she understands now why people have fought so hard against this. Carrie hopes others will come forward with their stories to help bring light to what has happened.

Carrie has filed a lawsuit to hold the government to account for encouraging Canadians to take the vaccine while suppressing and misinforming the public on their safety and efficacy.
