CITIZEN JOURNALISM

My paternal grandfather farmed in the hamlet of Manola, east of Barrhead (AB) from the early 1921 to 1958. He voted for the United Farmers of Alberta party, then the CCF and finally the NDP. Tommy Douglas was a hero in my family.

Over the decades, I've been on the 'left' on a host of political debates: against NAFTA, keeping Canada out of the Iraq War, and more. While I lived in Toronto, I was acquainted with Jack Layton through a United Church of Canada congregation we both attended. I supported Layton's successful campaigns to be a Toronto City Councilor in 1988 and 1994, and his race to be mayor of Toronto in 1991. I supported Layton as NDP leader from 2003 to 2011. When he died of cancer, I signed the book of condolences at Toronto City Hall. My vote for Joe Clark in 1979 was the exception to my mostly voting NDP since 1980.

Still, it disturbed me what Minister of Justice and Attorney-General, Jody Wilson-Raybould, said in her memoir about Justin Trudeau after the SNC-Lavalin affair. She met with Trudeau in Vancouver in February 2019. *"He asked if I trusted him... He told me I had not experienced what I said I did. He used the line that would later become public, that I had "experienced things differently." I knew what he was really asking. What he was saying. In that moment I knew he wanted me to lie — to attest that what had occurred had not occurred."*

During the push for the vaccines, I heard US Centers for Disease Control Director, Rochelle Walensky, tell CNN's Wolf Blitzer in early August 2021 that the Covid-19 vaccines didn't stop transmission, or prevent infection. In early 2022, I read a newly published Pfizer document, released by court-order, in the USA. Pfizer's Worldwide Safety Branch knew by February 28, 2021 that 1,223 people had died from taking their vaccine. This was detailed in their April 30, 2021 Cumulative Analysis of Post-Authorization Adverse Event Reports. I knew the vaccines were neither safe nor effective.

Growing up in Vancouver, I only had one friend who drove a truck. Yet, I didn't think requiring truckers that drive alone in their trucks to get vaccinated to enter Canada made any sense. I sensed that the Prime Minister's rhetoric about protesters headed to Ottawa was dubious. Curious about the depiction of those opposing the mandates, I walked over to a protest in downtown Vancouver on January 29, 2022. I heard former Global News staff Anita Krishna speak about the pandemic measures narrative being pushed by the media.

When Trudeau invoked the Emergencies Act, as "a last resort", at that moment I knew he was lying to Canadians. In February 2022, I became a citizen journalist writing and taking interviews about the convoy, the commission in Ottawa, and more recently the Coutts Four. In November 2022, I flew from Vancouver to Ottawa to attend the POEC for a week. Under the Trudeau Liberals, in the shift from sunny ways to stormy ways, I will continue to write about these times and separate fact from fiction.

THE PERSECUTION OF DETECTIVE HELEN GRUS

Part 1 - Overview

In September 2021 Helen Grus, an Ottawa Police Detective who worked on the sexual assault and child abuse unit sent an open letter to her colleagues regarding their Covid vaccine mandates in which she questioned if there will be any liability for injury, death or long term disabilities.

January 2022 Helen noticed a higher than normal rate of Sudden Infant Death and started questioning if the 9 deaths in the Ottawa area were relating to the vaccine status of the mother. While she was not assigned to these cases other officers were and were not investigating thoroughly. No one was questioning if the deaths could have anything to do with breast feeding with a vaccinated mother.

On January 30, Grus contacted one of the fathers about the investigation.

February 3 Grus was suspended without pay for failure to disclose her vaccination status.

Feb 4 Grus was suspended with pay and put under investigation for conducting an unauthorized investigation.

Before she could finish gathering evidence with intent to change the Sudden Infant Death Questionnaire she was suspended. In their investigation of Detective Grus the Ottawa Police wire tapped Grus and family under an urgent emergency provision of the criminal code, meant for abductions, murders and other urgent situations in order to protect the public. Former Toronto Police Detective Donald Best describes this as an incredible violation of privacy of not only Detective Grus but her family and friends. She has been charged with discreditable conduct for her investigation and accused of accessing police files and contacting a father of one of the children affected.

During Detective Grus' hearings evidence has been uncovered that during her interview with Professional Standards she handed over all of the evidence she had compiled including the Pfizer documents and to date nothing has been done with the evidence handed over. It has also come to light that it is not the father of the child that put in the complaint but another police officer.

On Monday the 14th, an email sent in September 2021 was exposed from the first witness, SGT Marc-Andre Guy, Grus' immediate supervisor, in which he instructed the unit that Helen Grus worked on "don't mention the Covid vaccines again."

Over the five day hearings the Police Prosecutor repeatedly objected to evidence brought forth from the defense including the Pfizer documents proving Pfizer knew of the harm that could be caused by the mRNA Covid vaccine to pregnant women and infants.



Hearings have been further scheduled for October. Freedom Corp Canada will continue to provide information going forward on this case up to and during future hearings.



THE LOSS OF INTEGRITY IN CANADA'S HEALTH SYSTEM

Hearing today of the death of Sheila Annette Lewis, we have to wonder how many more? How many more innocent people have to die at the hands of Canada's Covid policies? At the beginning of this year, we lost Garnet Harper, a young father who refused to take the injections while his doctors withheld a kidney transplant from him. Most recently we have lost Sheila Annette Lewis, a woman denied a transplant after having Covid twice, possessing natural immunity, who bravely stood and refused to give up her rights to bodily autonomy.

Sheila's fight began when she had been diagnosed in 2018 with a terminal illness in which she needed a transplant to survive. Sheila was put on the transplant list in May of 2020 and very quickly moved up in priority by October, however, May of 2021 she was given the ultimatum, if she wanted to stay on the list she needed to be vaccinated with the covid-19 shots. Sheila's fight, much like Garnet's, was not just for herself. She believed in our rights to bodily autonomy, she believed we should always have a choice and she took a stand. The Justice Center for Constitutional Freedoms and Canadians across the country stood with her.

Sheila brought forth a lawsuit in regards to her section 2(a), 7 and 15 Charter rights. Her legal fight led her all the way through the Court of Appeal up to the Supreme Court, who ultimately sentenced her to death. June 2023 The Supreme Court refused to hear her case. This did not stop Sheila, she was determined to make a difference and hold the health care system accountable.

Sheila and the JCCF filed a negligence claim against the hospital and doctors involved in denying her life saving treatment and a settlement was made. A provision was put in place where Sheila was prevented from talking about the settlement, but it was said to be satisfactory. However, if she breached the confidentiality, she would suffer serious consequences.

In Canada, we are told health care is a basic right, we pay for it through our taxes, we are promised the services that we need. It is shameful that a 58 year old woman, a prime candidate for transplant, a woman who wanted to live, has been prevented from seeing her grandchildren grow up because Canada has decided that politics are more important than life.

ULTRA VIRES LEADS TO ACQUITTALS

On July 31 Alberta Justice Barbara Romaine ruled that covid masking, capacity limits and social distancing, while she feels they were not against the Canadian Charter of Rights and Freedoms, that they must only be implemented by a public health official, “although Hinshaw was maligned during the pandemic and afterwards as the symbol of the restrictions, she was not in fact the final decision maker.” The judge expressed concerns that while Hinshaw may have outlined potential avenues to take in regards to these measures there is no evidence that she was the final decision maker. Finding that government officials had incorrectly interpreted section 29 of the Public Health Act she ruled that the measures implemented were considered ultra vires, done beyond ones legal power.

While these men have been acquitted of these charges, it does nothing to rectify the political persecution they endured over the last few years for standing for what they felt was right. It is expected going forward that remaining charges under these illegal measures will be dropped.



Pastor James Coates of Grace Life Church after being jailed for 35 days and vilified by the government and media, has since been acquitted of all charges related to these measures.

Pastor Timothy Stephens spent 18 days in jail following an arrest at Fairview Church based on a restraining order that had been amended to allow him to be at the Church. August 29th 2023, the Crown has withdrawn all charges remaining against him regarding the illegal mandates.



August 28th in Red Deer Alberta, Chris Scott, owner of The Whistlestop Cafe in mirror Alberta was acquitted of his charges under the same illegal mandates.
