BRINGING OURSELVES TO BEAR

I want to go back. Back before I was asked to be the spokesperson for the National Citizens Inquiry. Back before the Freedom Convoy. Back before I started writing for Gather Your Wits. In the before times, I had been a lifestyle television producer, a reporter, and a TV host. I'd directed a couple of short films, begun a stage and screen acting career, and written and performed a one-woman show before collapsing with chronic fatigue. After 13 years of illness, I was well enough to try to revive my acting career and moved back to Toronto. It was April 2020.

Timing is everything. As my industry shut down and I continued what had for me been 7 years of lockdown, I read and watched and learned. All those years of daily health research had paid off in terms of restoring my health, but also gave me resiliency around forced isolation. I had developed a spiritual muscle in solitude. I had learned how to find cutting edge health science. And, after decades of writing for other people, I had found my own voice. Combining my newly acquired strengths, I started a Covid blog with the tagline, "Spiritual principles, Scientific evidence, Health freedom." My goal was and is to empower people and to build bridges. Bridges between science and spirituality, left and right, those who see the falseness of the mainstream media messaging and those who don't yet know they've been lied to.

By the end of 2021, I was, like so many other Canadians, feeling bruised by punishing policies that defied previous perceptions of Canada as a tolerant and accepting country where freedom of choice was not only valued but staunchly defended. And then the truckers came.

I remember that event as the moment in time when I became patriotic. Though I was denied the ability to travel, I found someone with a car to drive me to Ottawa. As it did for so many, the Freedom Convoy changed my life. I never went home again, but instead continued travelling and writing about the many issues intertwined with Covid and the mandates. I spent my time between Ontario and Quebec, learning about First Nations, food sovereignty, and the many complex connections of control behind the Covid-19 narrative.

By the end of 2022, having been on the road for nearly a year of intense learning, I did a 10-day Vipassana silent retreat. I was able to still my mind and collect my thoughts. What became clear to me was that it was time to raise the bar. It was time to bring all my skills to bear. What has become clear since then is that we are all being called to raise the bar. To use whatever skills and resources we have to stand up and take responsibility for creating the world in which we want to live. In these unprecedented, uncertain times, we are being called to rise up and be our greatest selves.

That is the opportunity of this moment in history.

That is the opportunity of the National Citizens Inquiry— to come together as ordinary Canadians, to share our stories, to restore and express our compassion for the victims of destructive policies, and to hold those responsible to account. In the words of the Hopi elders, "We are the ones we' ve been waiting for."

FREEDOM CORP - THE TRIAL

CONVOY TRIAL Day 1 - Day 7

September 5th marked the first day of the trial of Tamara Lich and Chris Barber for their charges relating to the Freedom Convoy of 2022. The first day started off with the crown bringing forth the Carter application. This is formally known as the coconspirators' exception to hearsay. This is a rule in which the crown must prove beyond a reasonable doubt that a conspiracy has taken place and then, only after they have proved this, they must prove that the co-accused were both a part of that This then allows the crown to use conspiracy. statements made by each co-accused against each other. The crown is asking to use Facebook posts made by Tamara Lich and Chris Barber as evidence against the other. The discussion around this Carter application has yet, at day 7, to be resolved.

The crown in his opening statement accused Barber and Lich of encouraging protesters to cross the line for their political goals. He referred to the protest as anything but peaceful, claims they obstructed roads, interfered with police efforts and Ottawa citizens lawful enjoyment of personal property. The use of the word "occupation" in reference to the protest was contested in court by the defence. Greenspon addressed the court in saying "In a world where the trite, the mundane, and the trivial are called awesome and amazing, it is no surprise but nevertheless disappointing that the demonstration of January 26th to February 19th in the downtown of Ottawa would be referred to as an occupation, when the true sense of the word has far more serious implications and consequences for the people who have historically and for the people who are right now victims of it."

The crown went on through the first 7 days of trial to show many videos of both Tamara Lich and Chris Barber asking for peace, asking for unity and for everyone to remember there are citizens in Ottawa that didn't ask for them to be there and to show respect. The independent media covering the trial has all been questioning the crowns case as much of the evidence that is intended to prove the protest was not peaceful has only shown otherwise. Three witnesses are currently in the process of testifying, Sergeant Joanne Pilotte in regards to the Facebook posts, Constable Isabelle Cyr from the Police Liaison Team and Inspector Russel Lucas - Incident Commander.

There have been some issues with late disclosure from the that have not impressed Justice Heather Perkins-McVey and some apparent games being played in order to get evidence admitted. Justice Perkins-McVey remarked at one point that it seemed the crown was trying to get in the back door what he could not get in the front door. It has been apparent however that this judge has been very fair to both the crown and the defence in her decisions and has stuck strongly to the letter of the law. At this time, the defence is not cross examining Sergeant Pilotte about how she chose the videos. We have found out that she has not watched all of the videos that she downloaded but that she was given a list of videos by Detective Benson and so those are the videos she accumulated for the crown.

Thursday September 14th is expected to start with a continuing of the cross examination by the defence of Sergeant Pilotte and there is hope for some decisions involving the Facebook videos and posts with the Carter application.

POLICE ON GUARD FOR THEE

During the first winter of the Covid lockdowns a young man in Calgary Alberta was playing hockey at an outdoor rink with friends when he was approached by police for having a gathering and not wearing a mask. The situation quickly escalated to a degree where police pulled out their tasers. shouted obscenities and tackled the teenager to the ground. Calgary police denied any wrong doing in the instance while the images of two police officers pointing a taser at an unarmed teenage boy in skates circulated the internet. This incident was the fire that started what we now know as Police On Guard, a group of active duty and retired police officers, military, fire, corrections and border security officers. The mission in summary is to honor their Oath to uphold the Constitution of Canada and regain public trust lost due to the enforcement of emergency measures. (Full mission statement found on website listed below.)

As the word got out there was an influx of people wanting to come on board that believed in their mission and wanted to be a part of taking a stand, holding the government accountable for their charter violations and bringing dignity back to law Some members have come aboard enforcement. ready to stand publicly and some prefer to help in the background, but each member is passionate about standing strong for Canadians under what has become an overreaching government. Police on Guard has partnered with other like-minded groups such as The Constitutional Rights Center, Mama Bears Project, Mounties For Freedom, Veterans For Freedom, Canadian Citizens for Charter Rights and Freedoms, Stand up Canada, Health Professionals United and many more. Before long the group had started interviewing experts in an array of areas from legal and medical experts to political prisoners and public figures. In speaking with members of Police on Guard they feel that the information is best to come directly from the people involved, telling their stories and speaking on their expertise. Most recently a series called Demonstrably Unjustified which includes talks with such names as Kyle Kemper - Justin Trudeau's brother, Eva

Chipiuk - convoy lawyer and more.

POG has also taken part in a five hour digital conference on The Highwire with Del Bigtree and speakes to whistleblowers in the Whistleblower Wednesday series where they invite professionals to tell their stories about what is happening behind the scenes in healthcare around the covid protocols.

Currently the group is taking part in the federal employee lawsuit with Constitutional Lawyer Rocco Galati including over 90 employers, some of which are RCMP, Department of National Defence, Canada Border Services Agency and Canada Revenue Agency in regards to the vaccine mandates the government placed on workers with threat of job loss if they did not comply. This lawsuit is currently in the appeal process after Judge Fothergill wanted to strike a portion of the plaintiffs but it was decided to appeal it in it's entirety to include all plaintiffs.

Throughout their fight to stand for Canadians spokespeople from Police On Guard have said that while there has been some backlash it has been minimal and the support continues to grow amongst Canada's law enforcement officers. Their goal continues to be to hold the government authorities who perpetuated these acts upon Canadians accountable, continue to ask for evidence to justify their actions against Canadians and to hold the Charter of Rights and Freedoms above all. They want to express gratitude to those standing beside them and their message to Canadians is to link arms and continue to stand united together as one.

ACCESS GIVES YOU OPPORTUNITY

The Liberalist is a private Liberal Party database of voters that have taken part in partisan activities, taken lawn signs during elections or have recently supported the Liberal party. In April 2019 The Globe and Mail published an article detailing the use of the Liberal party database to conduct background checks and vet judicial candidates before appointment to judicial positions. In 2022 the Democracy Watch, a Canadian organization dedicated to holding the government accountable went to court to challenge the federal governments unconstitutional and too-political system for appointing judges to federal and provincial superior courts as well as courts of appeal.

Recently the National Post (NP) along with the Investigative Journalism Foundation (IJF) have finished an 8 month investigation in which they uncovered startling evidence of a potential pay to play system of appointing Canadas most influential justices. NP and IFJ have uncovered over three times as many Liberal donors have gained judicial appointments as Conservative since 2016. Out of 1,308 appointments by the Liberal government, both judicial and tribunal, since 2016 73.3% have been made by liberal donors, 22.9% conservative donors and 17.9% NDP donors.

While a spokesman from the office of the Prime Minister has claimed the process of judicial appointments is always based strictly on merit and the Liberalist database is not used, The Prime Minister's Office has previously indicated that the database has been used in the appointments according to an article by The Globe and Mail.

Three Albertans names were published by The National Post on August 28th indicating judicial appointments after membership in the Laurier Club. An elite club for Liberal party top donors.

Robert Armstrong of Calgary attended three fundraisers between July of 2018 and October 2020, two of which Justin Trudeau was present and one with Christia Freeland in attendance.

Michel Bourque of Calgary attended five liberal fundraisers between October 2017 and September 2021. Trudeau was in attendance for one with Freeland attending two others.

Kevin Feth also a Laurier Club member. All three of these names are similar to names of Alberta Judges appointed only months after their last attendance at one of these events.

A Jana Steele from Toronto attended two Liberal fundraisers in 2018 and 2019, one of which was headlined by Justin Trudeau at \$1625 per ticket. A Jana Steele from the same area has since been appointed to Superior Court Justice of Ontario.



In light of these appointments we must question if the integrity of the legal system has been compromised and do we want our government's, regardless of political affiliation, to be able to appoint donors, or should we be electing our judges through a democratic electoral process.
