## THE RECKLESS GAMBLE CANADA'S TROUBLING STANCE ON UKRAINE AND IT'S NEGLECTED MILITARY

The recent visit of Ukrainian President Volodymyr Zelensky to Ottawa isn't just a diplomatic occasion—it's a stark reminder of the recklessness displayed by Justin Trudeau and, astonishingly, the entire Canadian government, including the Official Opposition. In a cavalier move, Trudeau pledged another \$650 million to Ukraine, a non-NATO member and a country historically on NATO's adversarial list. This, while Canadian veterans are told they're asking for too much and our military stands at an all-time low in readiness.

This isn't merely fiscal imprudence; it's borderline irresponsibility. Western media outlets may craft rosy narratives of Ukrainian military success, but let's confront the dissonance here. If Ukraine is so victorious, why are they coming cap-in-hand for more financial aid? It's almost as if Trudeau and the Opposition are more committed to an ideological stance than to assessing the ground realities.

Furthermore, the audacity of Trudeau, backed by the Opposition, antagonizing Russia—a nuclear-armed nation with formidable cyber warfare capabilities—is nothing short of geopolitical naïveté. What's the strategy here, poking the bear while our own military stands gutted? The forces have become a shadow of their former selves, their time consumed by diversity lectures instead of combat training. Is this the military that will stand guard when that bear decides it's had enough?

And speaking of commitments, let's not overlook the blatant hypocrisy at play. Canadian soldiers sign on for "Unlimited Liability," essentially agreeing to lay down their lives for the country. Contrast that with Trudeau's galling statement that veterans are asking for more than the government can give. Is the irony lost on the Prime

Minister, who appears all too willing to sign checks worth billions to foreign nations, but hesitates when it comes to supporting our own?

Both Ukrainian and Canadian forces are facing dire straits, but for different reasons. While the Ukrainians suffer heavy casualties, largely glossed over by NATO countries, Canada's military battles its own existential crisis of purpose and effectiveness. And yet, the government's answer is to double, triple, even quadruple down on a failing foreign venture. It's as if Trudeau and the entire Canadian government are intent on setting the stage for a potential disaster.

In closing, the government's fiscal adventurism in Ukraine, coupled with its neglect of its own military and veterans, is not just misguided—it's a perilous game that jeopardizes both our international standing and national security. Before Trudeau and the Opposition engage in any more overseas largesse, perhaps it's time they focus on the crumbling institution at home that once stood as the epitome of Canadian valor and resilience.

## CONVOY TRIAL

### Day 8 - Day 13

Sgt Pilotte's testimony continued with videos of Chris doing his best to encourage peace and civility. A video was shown of Chris reacting to the burning of the Canadian flag to which he was not impressed, more videos of Barber talking about securing the area and keeping people safe. Pilotte has not viewed many of the videos that she is being asked about, she testifies that she was only told which videos to download by Detective Benson, and that she did not keep a list. It has been very clear throughout the trial up until this point there was an overwhelming message of peace and lawful activities. All videos being shown have been depictions of this message and nothing more. A lot of disclosure issues have been occurring, last minute disclosure or none at all.

The next witness called was on Day 9, SQ officer Captain Martel. Two interpreters were needed for this witness as he was a part of the green squad brought in from Quebec at the end of the protest. His testimony centers around what his job was and how they interacted with other squads to help bring the protest to an end. 150 officers were on his squad he testified, they were there for crowd control and spent a lot of time on standby. He testifies that the crowd was resisting moving, pushing back against the police. Videos were played of this time where "love over fear" can be heard being chanted in the background from the crowd of protesters. When Magas cross examines she asks about radio recording and notes to which there was nothing that the witness knew of.

Greenspon starts the 10th day by discussing what witnesses should be allowed. The judge says she will not allow impact statements to be admitted as evidence and she seems to have honored that throughout the trial thus far. The next witness brought in is Kim Ayotte, the General Manager for Emergency and Protective Services for the City of Ottawa, his job as he explains is to manage hazards

such as how citizens are affected. Ayotte's testimony centers around his work with the convoy organizers to move trucks, especially Barber. He confirms that emergency lanes were kept open. Greenspon presses Ayotte about his contradictions using his testimony at the POEC. Ayotte testified he knew the protest would be in Ottawa for an extended period of time however in court he had a different story. Greenspon is able to get Ayotte to admit that in reality, he was aware that convoy would be there much longer than 2 days.

One of the most interesting revelations over these days was the affidavit that Ayotte swore to on the 13th of February for the cities injunction to restrain persons unknown from violating bylaws. Defence exposes the dishonest behaviour that surrounded this affidavit as the tone of the affidavit was as though the convoy was not being cooperative, however Ayotte admits that he was getting cooperation from the organizers. He also failed to mention to Chipiuk in a meeting that same day that there was an application for injunction.

Last witness was the former chief of staff to Jim Watson, Serge Arpin. Communications between Arpin and Keith Wilson were positively in support of the moving of vehicles until everything was shut down on the morning of the 15th. Previous testimony showed this would be a project that would take multiple days however, the moving of trucks was shut down due to the window of allowed time being exceeded. The command change in the police seems to have been the real culprit. There was an issue with Arpin reaching out to the crown after being told not to contact anyone for what he said was to clarify something from his testimony, the judge said it was not appropriate.

Court is on break until October 11 2023, we will have some more details regarding the first 13 days of trial in issue 12.

## THE CELEBRATION OF EVIL IN CANADA'S PARLIAMENT

“We have here in the chamber today Ukranian Canadian world veteran from the Second World War who fought the Ukrainian independence against the Russians and continues to support the troops today...” applause roared in the Canadian House of Commons as then Speaker of the House, Anthony Rota, beamed with pride that this man was part of his riding. While the house stood in applause for this “Canadian Hero” as Rota described him, people around the world watched in horror. Who is this war hero the Trudeau’s government has lifted up? Who was the Ukranian soldier fighting for during the Second World War?

Canada was allied with the Soviet Union during WW2. Yaroslav Hunka, the Ukrainian at the centre of this embarassment, was the enemy. The Nazi SS Galizien, also known as the SS 14th Waffen Division was a voluntary unit of Nazi soldiers that committed some of the most heinous acts on Jews, Poles, and Ukranians. This unit surrounded villages, rounded up people in churches and murdered children in front of their parents. Hunka is a war criminal, a Nazi soldier that swore an oath of loyalty to Hitler.

As news of this rippled across the globe, Justin Trudeau and his MPs were quick to make excuses. It is the Prime Minister’s office that is in the end responsible for the vetting of guests in the HOC, it is especially their responsibility to vet someone that they will be hailing as a hero for the world to see. Trudeau was quick to deny that he had any responsibility, Karina Gould, liberal MP, stated in the HOC while denying the government knew of Hunka’s history that “when it comes to everyone that is invited to Parliament, of course that vetting happened.”

The question begs to be asked, if the vetting happened, how is it possible that the Trudeau government did not know of Hunka’s past? Has our government’s intelligence become so sub par that we allow a Nazi soldier to be celebrated in one of our most sacred of spaces.

In the days following, Anthony Rota has both made an apology and stepped down from his position as Speaker of the House. Conservative leader Poilievre has asked for an apology from Justin Trudeau for the incident and Melissa Lantsman, a jewish MP from Thornhill, whom Justin Trudeau once accused of standing with Nazis during Convoy, has asked him to take responsibility for the invitation. Karina Gould has since removed the photo of herself clutching the hand of Hunka proudly from her instagram and Trudeau has disappeared from Parliament, refusing to answer questions.

It is an incredibly sad day in Canada, when we find a man who has hidden from his crimes, is now hailed a hero and we see nothing more than the deflecting of blame from those who own the responsibility.

A lot of beauty has been born from the darkness of the last few years in Canada, we have shared some of this with you from the music of Greg Rider to the beautiful paintings of Tanya Richter. Many artists, musicians, and poets have poured their pain and struggle into their work and found their peace through it. Linda Jean is no different.

At the beginning of Covid lockdowns Linda had already been isolated on her farm due to a brain injury so she was used to the lifestyle of being alone a lot. As the lockdowns were implemented however, she felt that something was not right. Watching as the government was slowly stripping Canadians of their rights, watching people fall in line and do as they were told and seeing how people were struggling was an overwhelming time for her, she struggled herself with keeping her spirits up and maintaining hope that things would return to normal, she described this as a time she felt numb. On January 25th, Linda turned on her computer and everything changed.

Linda describe watching the convoy as the agony of a foot waking up from sleep. The flags and trucks, the people coming together, videos of overpasses full of hope, the realization that while she knew she was feeling down, she didn't know how numb she had been, how much sadness she had been suppressing. As these emotions started releasing she knew Canada was waking up with her, the heart of Canada, the kindness of people, Canadians love for one another, opening up again. "Canada isn't about greedy corrupt people, Canada is Canada because of the people."

Linda took a break from watching Convoy to go feed her birds and the pain and hopelessness she had been feeling quickly turned to joy, the birds had to wait, she felt a song coming through her soul, grabbed her guitar and started writing what is now Canadian Truckers.

When she talks about this day she describes this sense that not only did she feel she had to let the truckers feel her gratitude, she felt that the words were going from somewhere else, like she was just the vessel for the message. Linda decided to upload her song to YouTube, hoping somehow the truckers would see it and went off to do her chores. When she later checked on her video she realized it had gone viral in the freedom movement giving her hope that her message had made it to at least some of those truckers.

Fast forward until present day, Linda, after struggling to find someone to record and release the song for her was able to find a team to work with but as we are still seeing a lot of, they had to remain anonymous. The song was released on September 5th, the first day of trial for Lich and Barber, and can be found on streaming services like Spotify. Linda hopes that the message of the song will reach those who are still struggling with the sleeping foot, she feels she was given the opportunity to be a part of healing for some, the way the truckers were a part of that for her.
